### **ORGANIZATION**

The online catalogue lots have been organized according to vintage and wine-growing regions. The catalogue includes images of all 442 wine lots and can be filtered/searched by categories such as format (bottle size), country, region, price (range), and type. A search bar is also available to search for specific information, such as a particular wine or producer, vintages, and lot numbers.

### **WINE INSPECTION AND CONDITION NOTES**

As in previous years, all bottles from older vintages have been inspected. Where in any case considerations regarding the label, bottle condition, or the fill level are deemed to have a potential effect on the value or quality of the wine, particulars of that condition have been indicated. As is customary, somewhat greater ullage in older vintages is considered acceptable, provided that no leakage is evident, with no comment necessary.

### **WINE REVIEWS AND RATING**

For wine reviews, we have relied on the professional wine reviews of Robert Parker of the Wine Advocate, as well as other wine experts, whose numerical reviews are standards of reference for international wine enthusiasts. Wherever possible, the most recent review for a wine has been used.

The Terms and Conditions of the Toronto Symphony Orchestra Fine Wine Auction (the "Auction") supplement the Terms and Conditions of our Auction host, Iron Gate Private Wine Management/Iron Gate Auctions Inc. ([IronGateAuctions.com](https://www.irongateauctions.com)). The wines listed in the online Auction catalogue, as may be amended by announcement, are being offered for sale by the Toronto Symphony Volunteer Committee ("TSVC") and the Toronto Symphony Orchestra ("TSO") for its own account. By participating in this Auction, you agree to our Terms and Conditions. For this Auction, no buyer's premium will be added to your invoice, and no HST or other sales tax is applicable. Payment for your invoice can be made via the online Auction checkout system. Buyers are responsible for pick-up/delivery, and as detailed in the Shipping & Delivery section below, certain delivery costs may be added to your invoice. Bidders are legally responsible for all bids that they have placed, and all sales are final. Please review the full Terms & Conditions.

### Terms of Bidding

All bidders/purchasers of wine or other alcoholic beverages through the Auction must be 19 years of age or older. Proof of age may be required prior to the transfer of any purchased lots.

Bidders must register/sign-in for an account at [IronGateAuctions.com](https://www.irongateauctions.com) in order to participate in the Auction. The bidder's contact information is registered with Iron Gate Private Wine Management at and will be shared with the Toronto Symphony Volunteer Committee (TSVC) and Toronto Symphony Orchestra (TSO) for administrative purposes. Email addresses will be used for TSVC/TSO communications only.

All sales are final. No purchase can be returned, refunded or exchanged. Bidders are legally responsible for all bids that they have placed, even if a bid has been placed in error.

No buyer's premium will be added to the total purchase price. No HST/sales tax is applicable.

Successful bidders must pay for their purchases via the online Auction checkout system. No Auction lots will be released to the Buyer unless the purchase price has been paid in full.

### Bidding Notes

The online Auction opens on Tuesday, November 26, 2024 at 9 am EST., and closes on Tuesday, December 3, 2024 at 7 pm EST.

Bidding is anonymous. Bidding information and notifications for bids, outbids and successful bids on lots are administered by our Auction host, Iron Gate Private Wine Management. All bidding stops when the auction closes.

In the case of identical bids, the earliest received bid will take precedence. The Toronto Symphony Volunteer Committee, Toronto Symphony Orchestra and Iron Gate Private Wine Management are not responsible for technical errors or failures to execute bids.

The Buyer will be the highest bidder for the lot and the Buyer immediately assumes full risk and responsibility for the lot. When you register/sign-in for an account, you are agreeing to these terms and conditions.

Bid increments differ depending on the opening bid price of each lot. Bid increments are noted on [IronGateAuctions.com](http://IronGateAuctions.com) – [Auction Information](#).

TSVC/TSO reserves the right to withdraw any wines or other alcoholic beverages listed in the Auction catalogue at any time before the actual sale begins. ### **Conditions of Sale**

By bidding at Auction, bidders are bound by these Terms and Conditions, as amended by any announcements, lot descriptions or posted notices, which together form the contract of sale between the successful bidder (buyer), and (auctioneer).

TSVC/TSO reserves the right to withdraw any lot at any time before the actual sale. All lots are sold on an “as is, where is” basis, and TSVC/TSO makes no warranties or representation of any kind or nature with respect to any wine or other alcoholic beverages being auctioned, including but not limited to any representation or warranty of description, genuineness, attribution, provenance, or physical condition. All warranties and conditions implied by law are hereby excluded. Bidders and purchasers may not rely upon any statement of TSVC/TSO, oral or otherwise, other than as set forth in these conditions of sale. No person shall have recourse against TSVC/TSO or Iron Gate Private Wine Management for any irregularity or illegality in the Auction, or the conduct of the Auction, or of the wine or other alcoholic beverages.

By registering to bid, all bidders acknowledge that the wine or other alcoholic beverages offered for sale at the Auction may not have been tested by the Liquor Control Board of Ontario, and all bidders agree to sign a written acknowledgement stating same if requested by the TSVC/TSO or Iron Gate Private Wine Management.

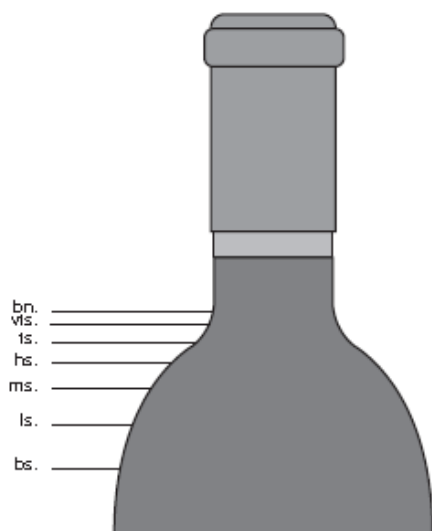
### **Pick-up & Delivery**

Upon completion of the Auction, successful bidders will be notified with information on how to pick up the purchased lot(s) from Iron Gate Private Wine Management, through their contactless pick-up process in Toronto. Successful bidders shall, upon completion of the Auction, immediately assume responsibility for, and risk of loss relating to, their purchased lots. If a successful bidder is unable to pick up their purchased lots, they can arrange for delivery\* at their own expense and risk. If any successful bidder fails to arrange for pick-up or delivery of their purchased lots within thirty (30) days, then Iron Gate Private Wine Management storage fees may be charged to and payable by such successful bidder starting on the 31st day after the completion of the Auction. No Auction lots will be released to the Buyer unless the purchase price has been paid in full.

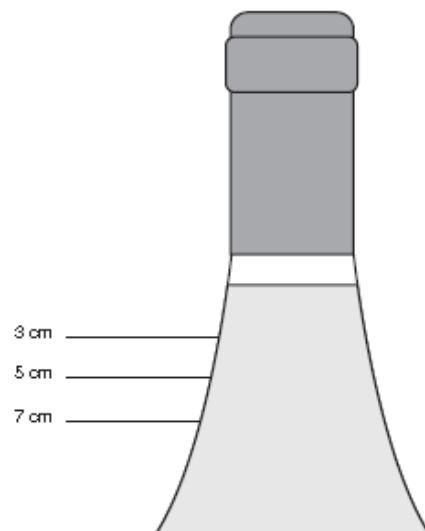
## Level/Ullage Description and Interpretations Page 4



### BORDEAUX LEVELS

For wines in bottles with defined shoulders including Bordeaux, Port and other wines, the level is measured and catalogued as follows:

- bn. BASE NECK: Perfectly good for any age of wine. Outstandingly good for a wine of 10 years in bottle, or longer.
- vts. VERY TOP SHOULDER
- ts. TOP SHOULDER: Normal for any Bordeaux 15 years old or older.
- hs. HIGH SHOULDER: Slight natural reduction through the easing of the cork and evaporation through cork and capsule. Usually no problem. Acceptable for any wine over 20 years old. Exceptional for pre-1950 wines.
- ms. MID SHOULDER: Probably some weakening of the cork and some risk. Not abnormal for wines 30-40 years of age. Estimates usually take this into account.
- ls. LOW SHOULDER: Risky and usually only accepted for sale if wine or label exceptionally rare or interesting. Always offered with low estimate.
- bs. BOTTOM SHOULDER: Not acceptable for sale unless a rare sort of bottle. Wine will usually be undrinkable.
- u. ULLAGE: Level.  
Example: (u. 2ts) means 2 bottles ullaged to top shoulder.
- oc. ORIGINAL CARTON
- owc. ORIGINAL WOODEN CASE



### BURGUNDY LEVELS

For wines in bottles with sloping necks, including Burgundy, German and other wines, the level between the cork and wine is measured and catalogued in centimetres

The condition and drinkability of Burgundy is less affected by ullage than its equivalent from Bordeaux. A 5-7-cm. ullage in a 50-year-old Burgundy can be considered normal, indeed good for age; 3.5-4 cm. excellent for age; 7 cm. rarely a risk.

Example: (u. 3x5cm) means 3 bottles ullaged 5 cm.

### BOTTLE SIZES

- hf. bt. HALF BOTTLE = 0.375 litres
- bt(s). BOTTLE(S) = 0.75 litres
- ltr. LITRE
- mag. MAGNUM = 1.5 litres, or two regular bottles
- d. mag. DOUBLE MAGNUM (Bordeaux, Port) = 3 litres
- jero. JEROBOAM (Burgundy, Champagne) = 3 litres
- jero. JEROBOAM (Bordeaux) = 5 litres\*
- imp. IMPÉRIALE (Bordeaux) = 6 litres
- meth. METHUSELAH (Burgundy, Champagne) = 6 litres
- salml. SALMANAZAR = 9 litres

\*Up to 1978, jeroboams were generally bottled in 4.5-ltr. bottles.
